


General Area Map Shane White Agent for Scarlett White #29-25



RULE I: MEETINGS

The Franklin County Board of Commissioners shall meet at 6:00 p.m. on:

Fourth Tuesday.....May

Fourth Monday.....January, February, March, April, June, July, August,
September, October, November

When the regular meeting date falls on a legal holiday, the commission may adjourn until the following day whether a quorum is present or not. In such case, an appropriate entry shall be made in the minutes.

RULE II: ORDER OF BUSINESS

The following shall be the order of business:

1. Call to order by the Chairman
2. Opening of the commission by the Sheriff's department
3. Pledge of Allegiance by the sheriff's department
4. Invocation
5. Roll Call _by the County Clerk
6. Approval of the minutes
7. Report of the County Mayor
8. Recommendation and other communications to the commission
9. Reports of the committees and department heads
10. Old business
11. New business
12. Elections
13. Benediction

RULE III: ELECT CHAIRMAN AND CHAIRMAN TEMPORE

Annually at its first session after September 1, the County Legislative Body shall elect a Chairman and Chairman Pro Tempore. The Chairman Pro Tempore shall preside whenever the Chairman is absent and at other times as the Chairman shall direct. In the absence of the Chairman and the regular Chairman Pro Tempore, the clerk shall call the meeting to order and hold an election to select a temporary Chairman Pro Tempore to preside over the meeting of the commission.

RULE IV: SHERIFF OR DESIGNEE

The Sheriff shall attend the board of commissioners while in session or designate some other officer for the purpose. If any member refuses to be in order, the Chairman shall have the right to call on the Sheriff, or his/her designated replacement, upon the commission to seat such member. If the member refuses to be seated, or to be in order, the Chairman may declare him in contempt of the commission shall not be reinstated until he/she has made public apology in open session to the commission and until the commission has accepted the apology.

RULE V: ADDRESSING THE CHAIR

Any member wishing to address the commission shall address the Chairman as "Mr. Chairman" and be recognized. No member shall speak until recognized by the Chairman.

RULE VI: NUMBER OF TIMES TO SPEAK ON A SUBJECT

No member shall speak more than once on the same subject for more than ten minutes, but a member may grant all or part of his/her time to another member. The Chairman of a committee, however, may speak as often as the Chairman recognizes him. The commission may, by majority vote, grant a member the privilege of extending the number of times he may speak on the same subject.

Any member who has spoken on a question before the commission may not call for the previous question until all members wishing to speak on the question have had an opportunity to do so.

The Chairman, and a majority of the members present, may grant permission to non-members of the commission to address the meeting. This rule shall not exclude reports by departmental heads that regularly report to the commission.

RULE VII: TO TABLE A MOTION

When a resolution or motion before the commission has been offered, or a motion to amend a resolution or a motion is before the commission, a successful motion to table the amendment will not affect the original motion.

RULE VIII: CHANGE VOTE

Any member of the board of commissioners may change his/her vote before the Clerk announces the result of a roll call. It shall be the duty of the Clerk at the end of each roll call to inquire of those who passed, or were absent when the roll was called if they desire to vote; also: if anyone who has voted wishes to change his/her vote. Then the Clerk shall announce the result.

RULE IX: VOTE TO TABLE

A motion to lay on the table, when properly seconded, takes precedence over all other motions and is not subject to discussion except that the original proposer of the resolution may speak to the subject. Thereafter, the commission must vote on the motion to lay on the table.

RULE X: CHAIRMAN VACATES CHAIR

The Chairman of the commission may speak on any question before it provided he vacates the chair then designates the Chairman Pro Tempore to preside. In the absence of the Chairman Pro Tempore, the Chairman may hold an election to select a temporary Chairman Pro Tempore who shall preside. The Chairman is then subject to the same rules as the other members of the commission. Upon the conclusion of his remarks, the Chairman shall return to the chair. Nothing in this rule shall prevent the Chairman from answering questions concerning subjects before the commission or from expressing his views thereon.

RULE XI: CALL FOR VOTE

The Chairman may call for a vote by voice or show of hands, however, the Chairman or any member of the commission may demand a roll call vote on any question. In that event, the Clerk shall call the roll and record the aye or nay vote of each member in the minutes. The roll call shall be rotated for each commission meeting beginning with the first meeting or each calendar year with the First District. In the event of a called meeting, the voting order of the previous regular meeting will be followed.

RULE XII: RESOLUTIONS

Any member of the board of commissioners may introduce any proposed resolution, and the Clerk or Chairman shall not receive any resolution that is not signed by at least two (2) members of the board of commissioners. However, a resolution may have as many members' signatures as there are members of the board of commissioners. But, the first two signing the resolution shall be deemed the authors for the purpose of debate.

Any member wishing to introduce a measure, which would require consideration or study, shall refer the matter to the Legislative Committee. The Legislative Committee will channel the motion to the correct committee for study.

Motion May Be Made Only by a Board of Commissioners Member.

1. Debating Motions: No motion shall be debated until the same is seconded and stated by the Chairman.
2. Motions In Writing: When a motion shall be made and seconded, it shall be reduced to writing, if desired by the Chairman or any member, delivered at the table, and read, before the same shall be debatable.
3. Motions During Vote: When by order of the board of commissioners, the Chairman has risen to submit a question, when there is a call for the "Ayes" and "Nays", or count of board of commissioners, no motion except a motion to adjourn, or to table the proposed action, shall be in order until the decision of the board of commissioners is declared by the Chairman.

4. Votes required to pass a Motion: To transact any business there must be a majority vote of the board of commissioners, not merely a majority vote of the quorum.
5. Motions Requiring Appropriations: All motions requiring an appropriation, requires a roll call vote.
6. By resolution, April 1969, a motion to reconsider may be made at any time before adjournment.

RULE XIII: NOMINATING COMMITTEE

At the September meeting, the board of county commissioners shall elect a Nominating Committee consisting of five (5) of its members for the purpose of submitting nominations to the commission for the standing and other committees required by the state statute. Nominations from the floor shall also be considered. The names of committee members shall be recorded in the minutes.

Each committee shall select its own Chairman on an annual basis. A committee may be called to meet by the Chairman at his/her own pleasure or by a majority of the members if the Chairman is absent or declines to hold a meeting.

Committee members shall serve for one year, or until the committee has been discharged, their replacement appointed, or unless otherwise specified by statute.

Each standing committee shall be composed of five (5) members, unless otherwise specified by statute, and shall be elected and/or appointed to annual terms, as provided above, in October of each year.

The following committees shall be designated standing committees of the Franklin County Board of Commission:

1. Building and Grounds Committee
2. County-wide Fire Department Committee
3. Finance Committee
4. Information Technology Committee
5. Health/ Insurance/ Retirement/ Welfare Committee
6. Law Enforcement Committee
7. Legislative Committee

8. Long Range Planning Committee
9. Nominating Committee
10. Road and Bridge Committee
11. Safety Committee
12. School Committee
13. Senior Citizens Committee
14. Soil Conservation Committee

Special Committees: The board of commissioners may from time to time appoint such special committees, as circumstances require, but such a special committee shall be disbanded when it completes its assigned work and in no case shall it exist longer than one year unless extended by the board of commissioners. No special committee shall be appointed for any purpose when there is a standing committee, commission, or board on the same subject.

Vacancies in Committees: Should, for any reason, one or more members of any respective committee vacate their position, the board of commissioners shall fill those vacancies in the same manner as the original members, unless otherwise specified by statute.

RULE XIV: ROBERT'S RULES OF ORDER

The commission will be governed by *Robert's Revised Rules of Order* on all subjects not covered by these rules or by statute.

RULE XV: RULING OF THE CHAIRMAN

The ruling of the Chairman on all issues of parliamentary order or procedure shall be binding upon the commission, except that his/her decision may be appealed to the commission. A two-thirds majority of the members present shall be required to overturn a decision of the chairman in these matters.

RULE XVI: SUSPEND RULES BY UNANIMOUS CONSENT

None of the foregoing rules of order shall be amended or repealed except by the affirmative vote of a majority of the members constituting the commission. However, the commission may suspend its rules by unanimous consent.

RULE XVII: FILING RESOLUTIONS REQUIRMENT OF 2/3 VOTE

Any proposal for an appropriation or for a resolution must be filed in writing with the Clerk ten (10) days prior to the commission meeting to allow regular committee action and inclusion in the packets. Any item not included in the packets shall require a 2/3 vote of the commission to allow the proposal before the commission.

RULE XVIII: STATE AMOUNT OF THE APPROPRIATION

Any resolution calling for an appropriation shall state specifically the amount of the appropriation and how the funds will be provided. Requests for appropriations from a department or an official must be accompanied by a detailed documented justification.

RULE XIX: RECEIVE AGENDA (3) DAYS BEFORE SCHEDULED MEETING

Agenda to Board of Commissioners Members: A copy of the agenda, attachments, and notice, of each board of commissioners meeting shall be made available to each board of commission member three (3) days before the scheduled meeting.

Reports: Each county department shall submit all reports, documents, or any other items to be considered by the full commission to the county mayor's office by 4:00 p.m. on Tuesday prior to the full commission meeting on the following Monday.

RULE XX: COUNTY ATTORNEY

The County Attorney shall attend all meetings of the board of commissioners to advise on matters of law. He shall, also, attend board of commissioners' committee meetings when called upon by the Chairman of the standing or special committee or a written request signed by the majority of that committee.

RULE XXI: MEDIA

Rules for radio and television broadcasting: (amended at September 14, 1992 Franklin County Commission.)

Any effort or attempt to disseminate information regarding the actions of the Franklin County Commission is welcome. The media may distribute or transmit their reports of the commission meeting in any manner that does not disrupt or cause undo confusion in the course of transacting the business of the citizens of Franklin County by the duly elected county commission.

- A. The nature of all commercial sponsorship shall be in keeping with the high degree of dignity of the board of commissioners.
- B. All broadcasts shall be at no cost to the county.

CONFLICT WITH THE LAW: In case any of these rules conflict with State or Federal Law, that part in conflict shall be null and void.
